Ghada Hatem Al-Tahir

António Guterres, the Secretary-General of the United Nations, appointed Ghada Hatem Al-Tahir Mudawi of Sudan as the Representative of the Secretary-General and Resident Coordinator in Kuwait. Ms. Al-Tahir boasts over 25 years of experience in humanitarian and development affairs, having held various key positions at the United Nations Office for the Coordination of Humanitarian Affairs in New York. Notably, she served as Deputy Director in the Division of Operations and Advocacy and briefly acted as director from March to August 2022. She has also served as Chief of Eastern and Southern Africa and as Acting Deputy Director for Middle East and North Africa, overseeing activities of the UN Office of the Coordinator for Humanitarian Affairs (OCHA) in those regions.

Before that, Ms. El-Tahir served as the Executive Director of the *Médecins Sans Frontières* (MSF) Gulf Cooperation Council Regional Office in Abu Dhabi; Country Director of MSF in Yemen and Nigeria and Nigeria Country Director of *Solidarités International* and of iMMAP.

Ms. Eltahir holds two master's degrees in development studies from Erasmus University-Institute of Social Studies, The Netherlands, and a Master of Science from Ahfad University, Sudan. She has also served on numerous international advisory boards and panels.

Ambassador Karen Hideko Sasahara

Ambassador Karen Hideko Sasahara assumed her duties as U.S. Ambassador to the State of Kuwait on November 26, 2023. Prior to that, she served as Deputy Assistant Secretary of State for North Africa from November 2020 to July 2022. Before returning to Washington, she served as Chargé d'Affaires of the U.S. Embassy in Amman, Jordan from March 2019 to August 2020, and Consul General in Jerusalem from







August 2018 to March 2019, where the focus of her work was diplomatic engagement and public outreach to the Palestinian people.

Her previous assignments include Senior Advisor in the Bureau of Intelligence and Research, Assessor on the Foreign Service Board of Examiners, Deputy Chief of Mission in Sana'a, Yemen and Foreign Policy Advisor to the Commanding General of Special Operations Command Central. Her earlier assignments include Baghdad, Beirut, Mexico City, London, Jeddah and Washington, D.C.

A native of Massachusetts, she holds an M.A. in Near East Studies from the George Washington University, and a B.A. in International Relations from the University of Wisconsin-Milwaukee. She is married to former Foreign Service Officer Michael Ratney.

Nisreen Rubaian currently serves as the Representative of the United Nations High Commissioner for Refugees (UNHCR) to the State of Kuwait. With over 20 years in refugee and humanitarian operations, she has led missions across Romania, Nauru, Pakistan, Sierra Leone, Egypt, the UAE, and Libya. Nisreen holds a Bachelor's degree in Law and English Studies from the University of Jordan and a Master's in Human Rights and International Law from the University of Bristol. Her extensive experience spans both operational and diplomatic roles in complex humanitarian settings.

Daniel A Degelow, MG

Major General Daniel A. Degelow is the Commander of the 38th Infantry Division. Prior to his current position, Gen. Degelow served as Deputy Commanding General (Sustainment) of the 38th Infantry Division and as the Assistant Adjutant General of Indiana.

His career highlights include service as the Aviation Operations Officer, Division Headquarters and Headquarters Battalion, 38th Infantry Division, Executive Officer, Headquarters and headquarters Company, 38th Combat Aviation Brigade, Aviation and Airspace Management Officer, TACT Command Post 38th Infantry Division, Liaison Officer, 38th Combat Aviation Brigade and Branch Chief, Joint Forces Headquarters-Indiana. His field grade command assignments are Rear Detachment Commander, 38th Infantry Division, Commander 38th Combat Aviation Brigade and Commander 2-238th General Support Aviation Battalion. Major General Degelow deployed as Aviation Task Force Liaison Officer, 2-238th General Support Aviation Battalion, 38th Infantry Division at USARCENT, Camp Arifjan, Kuwait in 2008-2009.

Major General Degelow earned a Bachelor's degree through Purdue University for Industrial Technology and a Master's of Strategic Studies from the U.S. Army War College. His military institutional training includes Armor, Aviation and Medical Service Corps Officer Basic Courses, Aviation Officer Advanced Course, Combined Arms and Services Staff School, Command and General Staff Officer Course, Dual Status Commanders Course (NORTHCOM), Joint Task Force Commanders Course (NORTHCOM) and the Army Senior Leader Development Seminar (SLDS).







Ambassador Steven Rapp

Ambassador Stephen J. Rapp served as the U.S. Ambassador-at-Large for War Crimes Issues from 2009 to 2015, heading the Office of Global Criminal Justice in the U.S. Department of State. Appointed by President Obama, he was confirmed by the Senate, and assumed his duties on September 8, 2009. Prior to his appointment, he served as Prosecutor of the Special Court for Sierra Leone beginning in January 2007, leading the prosecutions of former Liberian President Charles Taylor and other persons alleged to bear the greatest responsibility for the atrocities committed during the civil war in Sierra Leone. During his tenure, his office achieved the first convictions in history for sexual slavery and forced marriage as crimes against humanity, and for attacks on peacekeepers and for recruitment and use of child soldiers as violations of international humanitarian law.

From 2001 to 2007, Mr. Rapp served as Senior Trial Attorney and Chief of Prosecutions at the International Criminal Tribunal for Rwanda, personally heading the trial team that achieved convictions of the principals of RTLM radio and Kangura newspaper—the first in history for leaders of the mass media for the crime of direct and public incitement to commit genocide.

Mr. Rapp was United States Attorney in the Northern District of Iowa from 1993 to 2001, where his office won historic convictions under the firearms provision of the Violence Against Women Act and the serious violent offender provision of the 1994 Crime Act. Prior to his tenure as U.S. Attorney, he worked as an attorney in private practice and served as Staff Director of the U.S. Senate Judiciary Subcommittee on Juvenile Delinquency and as an elected member of the Iowa Legislature. He received his BA degree from Harvard College, and attended Columbia and Drake Law Schools and received his JD degree from Drake.

Mamadou Sow

Mr. Mamadou Sow serves as the Head of the International Committee of the Red Cross (ICRC) Regional Delegation for the Gulf Cooperation Countries (Bahrain, Kuwait, Oman, Qatar, Saudi Arabia and the United Arab Emirates). With nearly two decades dedicated to humanitarian service, he has served in some of the most challenging regions across Africa, Asia and the Middle East. His journey is shaped by a rich Muslim and Senegalese upbringing, complemented by a diverse educational background in the United States and Canada.

As the Head of Delegation at the ICRC for the Gulf Cooperation Countries, he works to promote and ensure respect for the rules of war, mobilize support for ICRC operations worldwide and engage in critical dialogues with governments, civil society, military and diplomatic officials. The ICRC is mandated with ensuring humanitarian protection and assistance for victims of armed conflict. It takes action in response to emergencies and at the same time promotes respect for international humanitarian law and its implementation in national law.







Michael A Fish, COL

Colonel Michael A. Fish is the Staff Judge Advocate of the 38th Infantry Division, based in Indianapolis, Indiana, and currently serving at Camp Arifjan, Kuwait. In his civilian career, the Honorable Michael Fish is the sitting Judge of Porter Superior Court #1, a general jurisdiction court located in Valparaiso, Indiana. Michael is the former owner of Michael A. Fish, Attorney at Law, where he practiced litigation, bankruptcy, and general practice law. He earned his bachelor's degree from Indiana State University, Juris Doctor from Valparaiso University School of Law, and Master of Strategic Studies from the U.S. Army War College. He is a member of the Indiana Judge's Association, Indiana State Bar Association, and Porter County Bar Association. Michael has served as a member of the Indiana Army National Guard since 1989. He previously deployed to Afghanistan, the Indo-Pacific, and Kuwait. He is admitted to practice in Indiana, the Northern District of Indiana, the Seventh Circuit Court of Appeals.

Dr. Felicity Gerry

Dr. Felicity Gerry KC is an international barrister at Libertas Chambers London and Crockett Chambers, Melbourne and Professor of Legal Practice at Deakin University. Labelled "The International Dynamo", Felicity has been recognised for her work across jurisdictions on career defining cases including in the UK Supreme Court on #jointenterprise law, the Australian High Court on rights to second appeal, a due diligence memorandum on investment listing on SGX for Justice for Myanmar, which led to the \$82m divestment of the Golden City scheme and for her role in saving a trafficked woman from death row in Indonesia. She is leading the legal petition for Christine Keeler to receive a posthumous pardon after the fallout of one of Britain's biggest ever political scandal, The Profumo Affair, in the 1960s. Her successful petition for mercy for Zak Grieve, a young Indigenous man in Australia, has been described as "rock star lawyering".

Felicity holds a PhD on human trafficking and is regularly called upon to handle complex and sensitive matters at trial and on appeal. She has appeared on all major news channels and is an expert on issues relating to women and law, technology and law and reform of justice systems. She is currently Senior Anti-Human Trafficking Expert Consultant and Trainer for Lawyers Without Borders.

There he was assigned as Chief of Legal Assistance and as the United States Foreign Claims







Commissioner for the countries of Kosovo, North Macedonia and Albania. From 2009 to 2011, he provided Legal Support Services at Camp Atterbury, Indiana for Soldiers mobilizing to Iraq, Afghanistan, and other overseas missions. In September of 2011, he was mobilized for a one-year tour in Egypt, where he served as Brigade Judge Advocate for Task Force Sinai. He has been a full time Legal Advisor for the Indiana National Guard since October 2012 to the present, with the primary duty of Human Resources Director from 2018 to 2022. John, who serves as treasurer of the International Bar Association Human Rights Law Committee and as an instructor for the American Red Cross International Humanitarian Law program, previously worked as a Human Rights Officer at the United Nations Assistance Mission for Iraq (UNAMI), reporting to the United Nations Office of the High Commissioner for Human Rights (OHCHR). He also acted as an International Humanitarian and Criminal Law Consultant and later Legal Officer for the United Nations Investigative Team to Promote Accountability for Crimes Committed by Da'esh/ISIL (UNITAD). He began his legal career as a law clerk for the Inter-American Court of Human Rights in San José, Costa Rica.

As a Reservist, he has served as Chief of National Security Law, International Law Officer, Prosecutor and Defense Counsel. His previous assignments include the Guantánamo Bay war crimes tribunals, the Pentagon and the U.S. Military Academy at West Point. He was competitively selected to represent







"unprivileged enemy belligerents" in the 9/11 case, one of the most complex and high-profile criminal cases in U.S. history, tried before the first American war crimes tribunals in over fifty years.

John is the author of *Public International Law: Conventions, Cases and Commentary*, published by Kluwer Law International in 2025.

Sara has published numerous articles in recent years on international law, sanctions, terrorism, human trafficking and free speech. Sara frequently speaks at international legal conferences and conducts trainings for legal professionals, corporations, financial institutions, government officials, military, and law enforcement regarding investigating and prosecuting war crimes, human rights, sanctions, compliance with international criminal law, national security, and counter—terrorism, including efforts in Ukraine, Sudan, South Sudan, Yemen, Egypt, Iraq, and the Gulf Region. Most recently, Sara was named as a senior board member for the Blue Tulip Human Rights Group and selected as an expert fellow for the Forum on the Arms Trade.

Jonathan Hafetz

Professor Jonathan Hafetz is an expert on constitutional law, national security, human rights, and international criminal law. He joined Seton Hall Law School in 2010. Professor Hafetz is the author of the books, *Punishing Atrocities through a Fair Trial: International Criminal Law from Nuremberg to the Age of Global Terrorism* (Cambridge Univ. Press 2018), and *Habeas Corpus after 9/11: Confronting America's New Global Detention System* (NYU Press 2011), which received the American Bar Association's Silver Gavel Award for Media and the Arts, Honorable Mention, and the American Society of Legal Writers, Scribes Silver Medal Award. He is also the editor of *Obama's Guantanamo: Stories from an Enduring Prison* (NYU Press 2016) and the co-editor (with Mark Denbeaux) of *The Guantanamo Lawyers: Inside a Prison Outside the Law* (NYU Press 2009). Professor Hafetz's scholarship has appeared in numerous publications, including the Yale Law Journal, UCLA Law Review, Columbia Law Review Sidebar, Wisconsin Law Review, William & Mary Law Review, International Journal of Human Rights, and Cambridge Journal of Comparative & International Law, and has been cited by numerous courts, including the U.S. Supreme Court. Professor Hafetz received a Fulbright Scholarship award for 2021-2022, and served as a Visiting Professor at Rikkyo University in Tokyo, Japan. From 2014-15, Professor Hafetz was a Visiting Research Scholar in the Program in Law and Public Affairs at Princeton University.

Professor Hafetz earned his J.D. from Yale Law School. He holds an M. Phil in Modern History from Oxford University and a B.A. from Amherst College. He previously received a Fulbright Fellowship to conduct research in Mexico. Following law school, Professor Hafetz served as a law clerk to Judge Jed S. Rakoff of the U.S. District Court for the Southern District of New York and Judge Sandra L. Lynch of the U.S. Court of Appeals for the First Circuit.

He previously held a position as a Senior Lecturer and Director of Undergraduate Studies at Brunel Law School, London (2007-2013). He has also taught and acted as a convenor of International Law & Islamic Law module at Durham Law School (2011-2013).

Prof Badar served as Senior Prosecutor and Judge in Egypt from 1997-2006. He is currently a Senior Expert for Euromed Justice IV, a project funded by the European Commission for enhancing Euro-Mediterranean mutual legal assistance on the investigation and prosecution of complex judicial cases i.e. terrorism, money laundering and cybercrime. He also served as a senior Police investigator in Egypt (1991-1997). He was a member (investigator) of the Bahrain Independent Commission of Inquiry to investigate and report on allegations of human rights violations during the civil unrest in Bahrain in February/March 2011.

He had the opportunity to work as an expert for the United Nations Interregional Crimes and Justice Research Institute (UNICRI), the United States Institute for Peace (USIP), the United Nations Office on Drugs and Crime (UNODC) and the Preparatory Commission for the Comprehensive Nuclear-Test-Ban Treaty Organization (CTBTO).
